Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended. The effect of the proposed Order will be:

(1) To prohibit the waiting of any vehicle between 8 a.m. and 6 p.m. Mondays to Fridays on the sides of road specified in Schedule 3 and 4 to this notice and, in addition, to prohibit loading or unloading between:

(a) 8 a.m. and 9.30 a.m. Mondays to Fridays on the sides of road specified in Schedule 3 to this notice; and

(b) 4 p.m. and 6 p.m. Monday to Friday on the sides of road specified in Schedule 4 to this notice.

(2) To prohibit the waiting of any vehicle at any time in the length or on the sides of road specified in Schedules 1, 2, 5 and 6 to this notice and, in addition, to prohibit loading or unloading between:

(a) 4 p.m. and 6 p.m. Monday to Friday on the sides of road specified in Schedule 1 to this notice;
(b) 8 a.m. and 9.30 a.m. Monday to Friday on the side of road specified in Schedule 2 to this notice; and

(c) 8 a.m. and 9.30 a.m. Monday to Friday on the sides of road specified in Schedule 6 to this notice.

(3) To close the gap in the central reservation of the Newport Shrewsbury Trunk Road (A4042) Malpas Road at its junction with Woodlands Drive.

Exceptions in the proposed Order will permit waiting for the following purposes:

- (a) picking up or setting down passengers;
