The Orders become operative on 7th October 1982 but if a person aggrieved by the Orders desires to question the validity of them, or of any provision contained in them, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of the Act or of regulations made under the Act has not been complied with in relation to the Orders, he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6, within 6 weeks from 30th September 1982 make an application for that purpose to the High Court.

*Huntingdon District Council (Footpath No. 12 at Yaxley)
Public Path Diversion Order 1982*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 30th September 1982 is about to be submitted to the Secretary of State for confirmation, or to be confirmed, as an unopposed Order, by the Huntingdon District Council.

The effect of the Order, if confirmed without modification, will be to divert that length of Footpath No. 12 at Yaxley which extends in an easterly direction for a distance of approximately 130 metres from the brook adjacent to the south-western extremity of the water-filled clay pit which lies due south of Orton brickworks, thence in a southerly direction for a distance of approximately 168 metres, thence in an easterly direction for a distance of approximately 210 metres in such a manner as it shall be replaced by a path which shall extend from a point at the brook approximately 130 metres east of its present crossing point in a general easterly direction parallel to the brook for approximately 222 metres, thence in a southerly direction for approximately 160 metres where it rejoins the existing Footpath.

The effect of the Order, if confirmed without modification, will be to divert that length of Footpath No. 1 at Buckden which extends in a general south-easterly direction for a distance of approximately 184 metres from the south side of the valley in the Recreation Ground in such a manner as it shall be replaced by a path which shall extend from the south side of the valley in the Recreation Ground in a south-westerly direction between Nos. 40 and 42 Cranfield Way for a distance of approximately 31 metres; thence in a general south-easterly direction for a distance of approximately 33 metres; thence in a general east-south-easterly direction for approximately 82 metres; thence in a south-south-westerly direction for approximately 95 metres; where it rejoins the existing footpath.

Footpath No. 4 Coleby Public Path Diversion Order 1982*

Notice is hereby given that the above-named Order, made on 24th September 1982, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order by the Lincolnshire County Council.

The effect of the Order, if confirmed without modification, will be to divert the above-named footpaths which form a continuous route running from Castle Lane, east of Somerton Castle, north-eastwards across O.S. Field Nos. 0004 and 0022 in Boothby Graffoe and O.S. Field No. 0001 in Coleby to an alternative route northwards along the western boundary of O.S. Field No. 0004; eastwards across the northern part of that field and the southern boundary of O.S. Field No. 0022; northwards across that field and then eastwards along the southern boundaries of O.S. Fields 0053 and 0001 and then north-eastwards across the latter field to join the existing path.

A copy of the Order and the map contained in it has been deposited at County Offices, Newland, Lincoln, and the offices of the North Kesteven District Council, Eastgate, Sleaford, and may be inspected during normal office hours. Any representation or objection with respect to the Order may be sent in writing to the Head of Secretarial and Legal Services, Lincolnshire County Council, County Offices, Newland, Lincoln, by 29th October 1982, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn the Lincolnshire County Council may, instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations or objections which have been duly made and not withdrawn will be transmitted with the Order.
