Notice is hereby given that the Greater London Council on 27th September 1982 made the above-mentioned Order under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

- 2. The general effect of the Order will be:
- (a) to further amend the Brent (Restriction of Waiting on Bus Stops) (No. 1) Traffic Order 1974, so that the restrictions on waiting by vehicles as imposed by that Order which apply on the bus stop which lies within the length of stree specified in Schedule 1 to this notice will cease to apply thereto;
- (b) to further amend the Brent (Restriction of Waiting on Bus Stops) (No. 1) Traffic Order 1977, so that the restrictions on waiting by vehicles as imposed by that Order which apply on the bus stop which lies within the length of street specified in Schedule 2 to this notice will cease to apply thereto;
- (c) to prohibit all vehicles from waiting between 7 a.m. and midnight throughout the week on the area of carriageway lying within or adjacent to the length of road specified in Schedule 3 to this notice and which area will be marked on the carriageway thereof by a yellow Bus Stop" marking and by double yellow lines within that marking;
- (d) to prohibit all vehicles from waiting between 7 a.m. and 7 p.m. throughout the week on any area of carriageway lying within or adjacent to the lengths of roads specified in Schedule 4 to this notice and which area will be marked on the carriageway thereof by a yellow "Bus Stop" marking and by a yellow line within that marking.
- 3. The prohibitions referred to in paragraph 2 (c) and (d) above will not apply:
 - (a) to a vehicle being used to provide a London bus service, whilst picking up or setting down passengers;
 - (b) to a vehicle being used for ambulance, fire brigade or police purposes; or
 - (c) in certain circumstances, to a vehicle being used in the service of a local authority, in connection with building operations, etc., adjacent to the bus stop or the removel of an obstruction to traffic or the repair, etc., of the highway or of any service therein; or
 - (d) to a vehicle waiting for not more than 2 minutes to enable a person to board or alight or to load or unload his personal baggage. The limit of 2 minutes will not apply if the person has serious difficulty in walking or is blind; or
 - (e) where the person in control of the vehicle is required by law to stop or does so in order to avoid an accident; or
 - (f) to anything done with the permission or at the direction of a police constable in uniform.
- 4. A copy of the Order, which will come into operation on 11th October 1982, and of the above-mentioned Orders of 1974 and 1977 (and of the Orders which have previously amended those Orders) can be inspected during

- normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Order was made in Room B.21, The County Hall, London SE1 7PR.

Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant sections of the Road Traffic Regulation Act 1967 or on the ground that any requirement of those sections of the Act or of section 84A, 84B or 84C of the Act or of any regulations made under the said section 84C has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.
