#### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Registrar's Office (Bank Buildings), at the Bank of England on Friday, 8th October 1982, at 1 p.m.; for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday, 11th October 1982 to Friday, 15th October 1982, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one halfpenny), which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Tenders must be made on the printed forms which may be obtained from the Bank of England.

8. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

### CHESTER CITY COUNCIL

#### TRAFFIC REGULATION ORDERS Hoole Lane Area/Victoria Road

Notice is hereby given that, on 29th September 1982, the Council of the City of Chester, pursuant to arrangements made under the Local Government Act 1972 with Cheshire County Council, made Orders under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974. The Orders and their effects are as follows; the usual exemptions from which will apply:

(1) *The City of Chester (Hoole Lane Area) (Prohibition and Restriction of Waiting) Order 1982* (Operative date, 4th October 1982)

(i) To prohibit waiting at any time on the following lengths of road:

- (a) *Hoole Lane*, westerly side, from a point opposite the southern boundary of No. 14 Hoole Lane in a northerly direction to its junction with Station View (new length).
- (b) *Hoole Lane*, easterly and south sides, from a point on the easterly side which is 40 metres south of the centre line of the bridge over the Shropshire Union Canal in a northerly then easterly direction to a point on the south side of Hoole Lane which is 25 metres east of the centre line of Station View (original length).
- (c) *Hoole Lane*, spur in front of Nos. 58 to 64 Hoole Lane, both sides, from its junction with the easterly side of Hoole Lane described in (b) above in an easterly direction to a point which is 25 metres west of its junction with Richmond Terrace, a distance of approximately 18 metres.
- (d) *Station View* (new length), both sides, from its junction with Hoole Lane for a distance of 10 metres in a northerly direction.
- (e) *Spital Walk*, west and south sides, from a point 50 feet (15.2 metres) north of its junction with Boughton in a northerly then westerly and northerly directions to its junction with Alma Street.
- (f) *Spital Walk*, east and north sides, from a point opposite the south side of Alma Street in a southerly then easterly direction for a distance of 54 metres.
- (g) *Boughton*, north side, from a point 15 metres east of the centre line of Hoole Lane for a distance of 20 metres in an easterly direction.

(ii) To prohibit waiting at any time between the hours of 8 a.m. and 6 p.m. Monday to Saturday on the following lengths of road:

- (a) *Hoole Lane*, spur in front of Nos. 58 and 64 Hoole Lane, both sides, from its junction with Richmond Terrace in a westerly direction for a distance of 25 metres.
- (b) *Richmond Terrace*, north side, from its junction with Hoole Lane (spur) in an easterly direction to its junction with the east side of Spital Walk a distance of approximately 96 metres.
- (c) *Richmond Terrace*, south side:
  - (a) from its junction with Hoole Lane (spur) in an easterly direction for a distance of 18 metres;
  - (b) from a point which is 40 metres east of its junction with Hoole Lane (spur) in an easterly direction for a distance of 23 metres;
  - (c) from its junction with the west side of Spital Walk in a westerly direction for a distance of 15 metres.
- (d) *Spital Walk*, east side, from its junction with the north side of Richmond Terrace in a southerly direction to a point which is 64 metres north of the south side of Alma Street.
- (e) *Spital Walk*, west side, from its junction with the south side of Richmond Terrace in a southerly direction to its junction with Alma Street.
- (f) *Station View*, (new length), west side, from a point which is 85 metres north of its junction with Hoole Lane in a northerly direction for a distance of 20 metres.

(g) *Station View*, (new length), east side, from a point which is 10 metres north of its junction with Hoole Lane in a northerly direction for a distance of 95 metres.

(h) *Hoole Lane*, easterly side, from a point 20 metres north of the southern boundary of No. 14 Hoole Lane in a northerly direction to a point which is 40 metres south of the centre line of the bridge over the Shropshire Union Canal.

(iii) To restrict waiting to periods of 30 minutes, return prohibited within 30 minutes between the hours of 8 a.m. and 6 p.m. Monday to Saturday on the following length of road:

*Hoole Lane*, easterly side, from a point opposite the southern boundary of No. 14 Hoole Lane for a distance of 20 metres in a northerly direction.

(2) *The City of Chester (Victoria Road) (Restriction of Waiting) Amendment Order 1982* (Operative date, 4th October 1982)

To amend the City of Chester (Victoria Road) (Prohibition and Restriction of Waiting) Order 1979 to provide for limited waiting, 1 hour in any 2 hours, on Victoria Road during the hours of 9 a.m. to 6 p.m. (Monday to Saturday) instead of during the hours of 8 a.m. to 6 p.m. (Monday to Saturday) as operates presently.

#### *The County of Durham (South Terrace, Bishop Auckland) (Prohibition of Waiting) Order 1982*

On the south side, from a point 63 metres from Waterloo Road, to Water Lane.

On the north side, from a point 131 metres from Stocks Road to Water Lane.

*Water Lane—*

On the south side, from Aqueduct Street right round the turning head and on the north side to a point 40 metres from Aqueduct Street.

On both sides, between Tulketh Road and the Tulketh Brow/Fylde Road junction.

(b) *Waiting prohibited between 8 a.m. and 6 p.m. Monday to Saturday inclusive*

Road linking *Pechell Street* to *Blanche Street*, on both sides, between the north-east side of the railway viaduct in Pechell Street and the north-east side of the railway viaduct in Blanche Street.

*Tulketh Brow—*

On the south side, between points 15 metres and 63 metres in a south-easterly direction from Waterloo Road.

On the north side, from Stocks Road to a point 131 metres in a south-easterly direction.

- (c) *No loading/unloading Monday to Saturday inclusive between 8.15 a.m. and 9.15 a.m. and between 4.30 p.m. and 6.30 p.m.*

*Water Lane*, on the south-east side, between West View Terrace and St. Mark's Road.

- (d) *No U-turn*

*Fylde Road*, vehicles travelling along the west-bound carriageway at the end of the central reservation or through any gap.

*Water Lane*, between Tulketh Road and Tulketh Brow at the end of the central reservation.

- (e) *Cycles only.*

*Newsham Street*, for a distance of 1 metre from Fylde Road.

*Water Lane*, from its junction with Tulketh Brow on the north side for a distance of 30 metres in a north-easterly direction.

The prohibitions will be subject to the usual exemptions.
