ROAD TRAFFIC ACTS

CAMBRIDGE CITY COUNCIL CITY OF CAMBRIDGE

Road Traffic Regulation Act 1967

Notice is hereby given that Cambridge City Council acting in pursuance of arrangements made under section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the County Council under sections 1, 31(1), 28, 35, 36, 37, 39 and 84D(1) of the Road Traffic Regulation Act 1967, as amended, made the orders given below.

The Orders and their effects are as follows:

1. *The City of Cambridge (Elfteda Road/Stanesfield Road/Thorley Road/Whitehill Road) (Prohibition of Waiting) Order 1982*

To prohibit waiting at any time on the following lengths of roads:

- (a) on both sides of Thorley Road from its junction with Whitehill Road eastwards for 10 metres;
- (b) on both sides of Whitehill Road from its junction with Thorley Road northwards for 15 metres and southwards for 15 metres;
- (c) on both sides of Stanesfield Road from its junction with Whitehill Road eastwards for 10 metres;
