ROAD TRAFFIC REGULATION ACT 1967 (AS AMENDED)

Surrey County Council (Station Avenue Service Road and Croydon Road) Caterham (Various Restrictions) Amendment Order 1982.

Notice is hereby given that the Surrey County Council propose to make an Order under section 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to:

- (a) create no waiting on Monday to Saturdays between 8.30 a.m. and 6 p.m. on the service road on the Supermarket and Car Park Development, Station Avenue, Caterham, on both sides for its entire length, a distance of approximately 212 metres (696 feet);
- (b) limit waiting to 1 hour with return prohibited within 1 hour on the south-western side of Croydon Road from a point on a line forming an extension of the southern flank wall of No. 57 Croydon Road (disused vehicle access of Hammond House) to a point 15 metres (49 feet) south-east of a line forming a projection of the south-eastern kerb-line of the Supermarket and Car Park Service Road, a distance of approximately 27 metres (89 feet)
- (c) prevent any vehicle travelling in generally a north-westerly direction along the service road from its junction with Station Avenue to its junction with Croydon Road;
- (d) prevent any vehicle from turning right into Station Avenue from the service road.

The usual exemptions for loading and unloading vehicles boarding and alighting from vehicles using vehicles for works on or adjoining those sides of road the maintenance of the road and the services therein and for disabled person's vehicles in accordance with the orange badge scheme will be included in the proposed Order.

STAFFORDSHIRE COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT 1967

The Staffordshire County Council (Mill Lane, Wetley Rocks) (Prohibition and Restriction of Waiting) Order 1982.

Notice is hereby given that the Staffordshire County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974.

When this Order comes into effect you will not be allowed to leave your vehicle at any time on both sides of Mill Lane, Wetley Rocks, from its junction with Main Road, A520, north-westwards for a distance of 20 metres.

Exceptions will permit waiting for the purposes of taking up and setting down of passengers, loading or unloading goods, for vehicles displaying a Disabled Person's Badge, and where necessary in connection with the maintenance of roads and the supply of gas, electricity and water, and for emergency service vehicles.

Full details of these proposals are in the draft Order which together with a map showing the restricted areas and a statement of the County Council's reasons for proposing to make the Order may be examined during normal office hours at my office and during normal opening hours at the Werrington Branch Library, Ashbank Road, Werrington.
