*The West Yorkshire Metropolitan County Council (Kirklees)
(Traffic Regulation) (No. 21) Order 1981*

Notice is hereby given that the West Yorkshire Metropolitan County Council have made the above Order under their powers in the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit pedestrians from entering or proceeding in the south-westbound (towards Mirfield) carriageway (including the verge and central reservation) of Webster Hill (A644) at Dewsbury extending from the railway bridge near the John F. Kennedy Public House to a point 99 metres north-east of Watergate Road.

A copy of the Order which comes into force on 25th October 1982 and of a map showing the length of road affected, may be examined during normal office hours at the Reception Desk, Main Entrance, County Hall, Wakefield; the County Council's Traffic Unit, Bishopgarth, Westfield Road, Wakefield and at the Kirkless Metropolitan Council's Office, Town Hall, Dewsbury.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirements of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the date upon which the Order was made (i.e. 28th September 1982) apply to the High Court for this purpose.
