*The Borough of Blackburn (Grosvenor Way) (Prohibition of Driving) Order 1982*

Notice is hereby given that the Blackburn Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Lancashire, in exercise of the powers of the said County Council, propose to make an Order under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 the effect of which will be to prohibit the driving of motor vehicles in the length of road set out in the Schedule to this notice.

Certain exemptions will apply, including (inter alia) provision to enable goods to be loaded on or unloaded from vehicles and to allow hackney carriage access to and to ply for hire from the hackney carriage stand.

*The County of Cleveland (Yarm High Street) (Street Parking Places for Disabled Persons' Vehicles) Order 1982.*

Notice is hereby given that on 5th October 1982, the County Council of Cleveland made the above-named Order under section 28 (1), 31, and 84D (1) of the Road Traffic Regulation Act 1967:

The effect of the Order will be:

- (i) to bring into effect an Order to prohibit vehicles other than disabled persons' vehicles from parking on the two parking bays adjacent to No. 44 High Street, Yarm;
- (ii) to revoke the County of Cleveland (Yarm High Street) (Experimental Disc Parking Control) Order 1981 in so far as it relates to the two parking bays.
