SOUTH YORKSHIRE COUNTY COUNCIL

South Yorkshire County Council (Barnsley) (Traffic Regulation Consolidation) Order 1981 (Amendment No.) Order 1982.

Notice is hereby given that the South Yorkshire County Council propose to make an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the proposed Order will be to prohibit waiting at any time by vehicles in the following side of road:

Eldon Street North, north-west side, from a point 60 metres south of the junction with the southern kerb-line of Bridge Street to a point 20 metres north of the junction with the northern kerb-line of Bridge Street.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

South Yorkshire County Council (Manchester Road (A628) Thurlstone) (Restriction of Waiting) Order 1982

Notice is hereby given that the South Yorkshire County Council propose to make an Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the proposed Order will be to prohibit waiting by vehicles between the hours of 8 a.m. and 6 p.m., Monday to Saturday (inclusive) in any of the sides of road specified in the Schedule to this notice.

Manchester Road, A628

North side:

(i) Commencing at a point 32 metres west of the point opposite the north-west kerb-line of Savile Lane for a distance of 20 metres in a westerly direction;

(ii) from a point opposite the north-west kerb-line of Savile Lane for a distance of 22.5 metres in an easterly direction.

South side:

(i) From a point 30 metres west of its junction with the north-west kerb-line of Savile Lane for a distance of 44 metres in a westerly direction;

(ii) from its junction with the south-east kerb-line of Savile Lane for a distance of 16 metres in a south-westerly direction.

Savile Lane, south-east side, from its junction with the southern kerb-line of Manchester Road for a distance of 9 metres in a south-westerly direction. (497)

Notice is hereby given that the West Yorkshire Metropolitan County Council have made the undermentioned Orders under their powers in the Road Traffic Regulation Act 1967, as amended, the effect of which is:

Ref. TRO/C/82/16. *The West Yorkshire Metropolitan County Council (Calderdale) (Traffic Regulation) (No. 16) Order 1982.*

(a) To convert the existing "Residents Only" Parking Places (2 No.) in Lister Court, Halifax, to parking places for general public use and to limit their use to 2 hours maximum stay (return prohibited within 2 hours) between 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive.

(b) To extend the scope of the "Residents Only" parking place in St. James Court, Halifax, to include the occupants of premises Nos. 10, 12, 14 and 16 St. James Road.

Ref. TRO/C/82/17. *The West Yorkshire Metropolitan County Council (Calderdale) (Traffic Regulation) (No. 17) Order 1982.*

(a) To introduce limited waiting of 2 hours duration (return prohibited within 2 hours) between 8 a.m. and 6 p.m. on Mondays to Saturdays in a length of Chapeltown, Halifax (north side), in place of the existing daytime waiting ban.

(b) To introduce a daytime waiting ban (8 a.m. to 6 p.m. on Mondays to Saturdays) in a length of Chapeltown (south side) in place of the existing limited waiting.

A copy of the Orders which come into force on 25th October 1982 together with a map showing the roads in question may be examined during normal office hours at the Reception Desk at the main entrance to the County Hall, Wakefield, and at the County Council's Offices at Powell Street, Halifax.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirements of that Act or of any Instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the date upon which the Order was made (i.e. 5th October 1982) apply to the High Court for this purpose.
