Notice is hereby given that on 8th September 1982 the Ceredigion District Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert the public right of way running from the gully at the eastern end of O.S. enclosure number 3952 along the cliff side of the hedgebank and fence boundary of O.S. 3952 in a westerly direction for a distance of approximately 140 metres from the gully to a line running from the gully situated at O.S. enclosure number 3952 into O.S. enclosure number 4943 and then along the field side of the hedgebank in O.S. enclosure number 2943 to a point approximately 140 metres from the gully.

The Order becomes operative as from 15th October 1982, but if a person aggrieved by the Order desires to question the validity thereof or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1980, or on the grounds that any requirements of the Act, or any regulation made thereunder, has not been complied with in relation to the Order he may, under Schedule 2 of the Act of 1980, as applied by paragraph 5 of Schedule 6 of the Act, within 6 weeks from 15th October 1982, make an application for this purpose to the High Court.
