(c) on behalf of a water authority and engaged upon the laying, inspection, maintenance, alteration, repair, re-newal or removal of any public sewer under, in, on, over, along or across the highway or any land adjacent to the highway.

### **ROAD TRAFFIC ACTS**

#### AVON COUNTY COUNCIL

County of Avon (St. John's Street Area, Bedminster, Bristol) (Prohibition and Restriction of Waiting) Order 1982

Notice is hereby given that on 12th October 1982 the County Council of Avon made an Order under sections 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended, the effect of which is:
(1) to prohibit any vehicle waiting at any time in the lengths of road specified in Schedule 1 to this

- notice ;
- (2) to prohibit any vehicle waiting between the hours of 8 a.m. and 6 p.m. on Monday to Saturday (inclusive) in the lengths of road specified in Schedule 2 to this notice;
- (3) to restrict any vehicle waiting for more than 1 hour in any 2 hourly period between the hours of 8 a.m. and 6 p.m. on Monday to Saturday (inclusive) in the lengths of road specified in Schedule 3 to this notice;
- (4) to prohibit any vehicle loading or unloading goods between the hours of 8 a.m. and 9.15 a.m. or between 4.45 p.m. and 6 p.m. on Monday to Friday (inclusive) in the lengths of road specified in Schedule 4 to this notice;
- (5) to revoke and to consolidate provisions of Orders currently in operation in the immediate area

The above items will be superseded by the provisions of the traffic Order which protects bus stops.

The Order will come into operation on 25th October 1982 and a copy thereof together with a map may be inspected at the undermentioned offices (6th floor) during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.
