Footpaths in the Parishes of Hopton Wafers and Milson

Notice is hereby given that Shropshire County Council proposes to apply to Bridgnorth Magistrates Court sitting at the Council Offices, Westgate, Bridgnorth, Shropshire, at 10 a.m. on Monday, 15th November 1982, for a series of Orders pursuant to section 116 of the Highways Act 1980 authorising the diversion or closure of various footpaths in the parishes of Hopton Wafers and Milson.

The grounds for the diversions will be that the footpaths as diverted will be nearer or more commodious to the public. The grounds for the closures will be that the footpaths to be closed are unnecessary.

The effect of the Orders, if made, will be as follows:

Order 2/82. FP14 and FP15 Hopton Wafers

To close that part of FP15 from its junction with the access road to the property known as Upper Down for about 150 yards south-east to its junction with FP14.

To close that part of FP14 from its junction with FP15 adjacent to the property known as Upper Down for about 433 yards south-east, then south-west to the boundary of Milson Parish.

The diverted path FP15 will follow the access road to the property known as Upper Down for approximately 140 yards south-south-east Grid Reference No. 63017451.

The diverted path FP14 will run 33 yards west from the existing junction between FP14 and FP15 to join the farm track and will then follow that track for about 333 yards south, then south-east to the boundary of Milson Parish.

Order 3/82. FP15 Milson

To close that part of FP15 from its junction with FP14 Hopton Wafers at the parish boundary for about 1,366 yards south-west, then generally south-east to Grid Reference No. 63607334, about 100 yards north-west of its junction with FP14 Milson. The diverted path FP15 will run from the boundary of Hopton Wafers Parish at Grid Reference No. 63147425 for a distance of about 1,283 yards south-east to rejoin the original path FP15 at Grid Reference No. 63607334.

A new public footpath will be created to continue from the eastern end of FP44 Coreley for about 317 yards north-east to connect with the diverted line of FP15 at Grid Reference No. 63207407.

Order 4/82. FP15 Milson

The path will be closed from its junction with FP16 South Oak Farm for about 233 yards south-east to its junction with the existing lane.

A new path will be created to run from the southern end of FP16 south along the farm track at New House Farm to join the existing lane in about 150 yards.

Order 5/82. FP14 Milson

The whole of this path will be closed from its junction with FP15 to the junction with the existing lane 120 yards north-east of the property known as The Butts.

Order 6/82. FP16 Milson

To close footpath FP16 from a point about 150 yards south-east of its junction with FP50 to its junction with FP15. The diverted path FP16 will run from the northern closure point south-west then south to join FP15 at Grid Reference No. 63607334.

The proposals are shown on a plan deposited at the Public Library, Cleobury Mortimer, Shropshire, where they may be inspected during opening hours and at the County Secretary's Department, The Shire Hall, Abbey Foregate, Shrewsbury, where they may be inspected during normal office hours.
