THE HIGHWAYS ACT 1980

*The Mid Glamorgan County Council (Abercynon to Beacons Reservoir Classified Road) (Hirwaun By-Pass A4059 to Mount Pleasant Principal Road) (Side Roads) Order 1982.*

The Secretary of State for Wales hereby gives notice that he has confirmed the above Order which was made by the Mid Glamorgan County Council under sections 14 and 125 of the Highways Act 1980 and which as confirmed, provides for authorising the Council:

- (a) to improve, raise, lower or otherwise alter highways;
- (b) to stop up highways;
- (c) to stop up a private means of access;
- (d) to provide a new private means of access;

all on or in the vicinity of the route of the Abercynon and Beacons Reservoir A4059 classified road at Mount Pleasant, Hirwaun.

Copies of the Order, as confirmed, and of the relevant plans may be inspected free of charge at all reasonable hours at the offices of the Mid Glamorgan County Council, County Hall, Cathays Park, Cardiff, the Cynon Valley Borough Council, Council Offices, Rock Grounds, Aberdare, and at the Welsh Office, Government Buildings, Ty Glas Road, Llanishen, Cardiff.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 21st October 1982, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
