

The alternative route for eastbound traffic will be via Hartington Road, Borough Road and Linthorpe Road and for westbound traffic will be via Linthorpe Road, Borough Road and Hartington Road.

The Order will come into operation on 22nd October 1982, and shall continue in force for a period of 6 months from that date.

A copy of the Order and a plan showing the area may be examined during normal office hours at the offices of the County Secretary, Municipal Buildings, Middlesbrough and the Central Library, Dunning Street, Middlesbrough.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date of this notice apply to the High Court for this purpose.

CORNWALL COUNTY COUNCIL

The County of Cornwall (Troon) (Prohibition of Waiting) Order 1982

Notice is hereby given that on 11th October 1982, the Council made the above Order (operative from 25th October 1982) to regulate traffic at Troon, Camborne (subject to the normal exceptions operating in Cornwall, including the disabled persons exception) by prohibiting the waiting of vehicles at any time in the lengths of road specified in the Schedule.
