The North Yorkshire County Council (Grange Farm East Heselton) Footpath Creation Order 1982

Notice is hereby given that the above-named Order, made on 12th October 1982 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order by the North Yorkshire County Council.

The effect of the Order, if confirmed without modifications, will be to create two sections of public footpath in the parish of Heselton (i) commencing on the western boundary of field O.S. 5459 and leading eastwards for 450 metres to where it joins a section of already Definitive footpath and (ii) commencing on the western boundary of field O.S. 0002 at the Definitive footpath and leading easterly along the northern side of a post and wire fence for 550 metres, then turning northwards along the eastern boundary of field O.S. 0002 for 135 metres.

A copy of the Order and map contained in it has been deposited and may be inspected free of charge at Room 14, County Hall, Northallerton and at N.Y.C.C. Divisional Office, Westgate, Old Malton, Malton, during normal office hours.

The North Yorkshire County Council Footpath at Willow Grange, Sowerby Diversion Order 1982

Notice is hereby given that on 12th October 1982 the North Yorkshire County Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert the public footpath at Sowerby (Thirsk) approximately 142 metres in length which crosses diagonally field No. O.S. 2155 commencing at point A on the deposited plan adjacent to the western field boundary 152 metres from where the footpath leaves Ox Moor Lane to a stile at point B on the deposited plan on the northern boundary of field No. O.S. 2155, to a new route commencing at the said point A on the western boundary of field No. O.S. 2155 and following the western and northern boundaries of field No. O.S. 2155 to the said point B, a distance of approximately 180 metres.

A copy of the Order as confirmed and plan contained in it has been deposited at the County Council's Highways Divisional Office, Norby, Thirsk and may be inspected free of charge during normal office hours.

The Order becomes operative as from 26th October 1982, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1980, as amended or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 3rd December 1982, make an application for the purpose to the High Court.

The North Yorkshire County Council Footpaths Nos. 18 and 19 Thoraby Diversion Order 1982

Notice is hereby given that the above-named Order, made on 12th October 1982, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order by the North Yorkshire County Council.

The effect of the Order, if confirmed without modification, will be to divert the public rights of way known as footpaths 18 and 19 in the Parish of Thoraby. The section of footpath to be diverted commences at a point in O.S. field No. 357 at the existing hand gate in the southern wall which is situated 88 metres from the south-west corner of the field at Grid Reference SD 9689 8613. It runs in a generally north-westerly direction to another hand gate in the west wall of that field situated 5 metres from the north-west corner of the field and then proceeds generally westward along the south bank of Gayle Ing Beck for approximately 40 metres turning north over a footbridge across the beck. It then runs generally northward through a small sheep fold to a stile in the southern wall of a small wooded croft in O.S. field No. 361 which is situated 4 metres from the south-west corner of the croft. It continues in the same direction to a gate dividing the croft from the garden at Gayle Ing House which is situated 11 metres from the north-east corner of the croft. From this point the path runs in a generally north-east direction circling anti-clockwise round the east end of the house to a hand gate in the northern wall of the garden in O.S. field No. 360 situated 8 metres from the north-west corner of the garden at Grid Reference SD 9683 8631. At this point the path divides, one path travelling in a slightly west of north direction following the west wall of O.S. field No. 352, the other path travelling east along the southern wall of that field. The diversion ends approximately 14 metres along each of the two branches after the diversion.

The section of footpath to be created commences at a point in O.S. field No. 357 at the existing hand gate in the southern wall at Grid Reference SD 9689 8613 at which point a signpost will be erected. It runs in a generally north-north-east direction to the gap in the southern wall of O.S. field No. 358 at which point a stile will be constructed. It continues in the same direction to a point on Gayle Ing Beck 33 metres east of the boundary wall with O.S. field No. 359 where a footbridge will be constructed, continuing again in the same direction to a point immediately east of the existing hand gate in the north wall of O.S. field No. 358 which is situated immediately east of Holme Barn at Grid Reference SD 9699 8634, at which point a stile and a signpost will be constructed. At this point the path divides, one path travels in a north-easterly direction to join the existing footpath No. 18, the other path runs in a westerly direction to join existing footpath No. 18. A small section of footpath will also be created near Grid Reference SD 9683 8631 so as to link the western end of footpath 18 with the southern end of footpath 19 along a diagonal line some 20 metres long across the south-west corner of O.S. field No. 352.
