Royal County of Berkshire (Bridge Avenue, Maidenhead) (Traffic Regulation) Order 1982

Notice is hereby given that the Berkshire County Council have made an Order under sections 1 and 15 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which is to:

1. Designate the part of the highway specified in Schedule 1 to this notice as a public service vehicle stand where public service vehicles may wait for a maximum period of thirty minutes.
2. Prohibit any vehicle proceeding in the length of road specified in Column 1 of Schedule 2 to this notice to proceed in a direction other than that specified in relation to that road in Column 2 of Schedule 2 to this notice. The Order will come into operation on 31st October 1982.

Copies of the Order and relevant map can be inspected during normal office hours at the offices of the Borough Secretary, Royal Borough of Windsor and Maidenhead, Town Hall, St. Ives Road, Maidenhead, and at the County Secretary's Department at the address given below.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended as aforesaid, or on the grounds

that it has not been complied with in relation to the Order, you may, within 6 weeks from 25th October 1982, apply to the High Court for this purpose.
