The Trunk Road (Various Roads, Holyhead) (Prohibition and Restriction of Waiting) Order 1983

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended, which shall come into operation on 24th February 1983. The effect of the Order is to revoke the existing limited waiting on the side of roads specified in the Schedule to this notice.

A copy of the Order, a copy of the Order to be revoked, together with a plan and a statement of reasons for making the Order, may be seen during normal office hours at the

offices of the Isle of Anglesey Borough Council, Borough Council Office, Llangefni, Monday to Friday, and at their area office at Newry Street, Holyhead, between the hours of 9.30 a.m. and 4.30 p.m. during a period of 6 weeks from 27th January 1983.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any Instrument made under it, has not been complied with in relation to the Order, you may, within the aforesaid period of 6 weeks apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

The east side of that length of the London-Holyhead Trunk Road (A5) known as Victoria Road, at Holyhead, in the county of Gwynedd, which extends from a point 303 yards north of its junction with Holborn Road in a southerly direction to a point 260 yards north of that junction. (3 SI)
