

(b) the said outboard motor was part of the tackle, apparel or furniture of the said dinghy, which is itself liable to forfeiture as above.

Whereby and by force of sections 141 (1) (a) and 141 (2) of the Customs and Excise Management Act 1979 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within 1 month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in England and Wales who is authorised to accept service of process and to act on your behalf.
