THE IMPORTED FOOD REGULATIONS 1968 (AS AMENDED)

Sweden: Official Certificates

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales acting jointly in exercise of the powers conferred on them by the Imported Food Regulations 1968 (S.I. 1968 No. 97), as amended by the Imported Food (Amendment) Regulations 1973, 1979 and 1981 (S.I. 1973 No. 1351, S.I. 1979 No. 1426 and S.I. 1981 No. 1085) give notice that they hereby recognise, subject to the conditions hereinafter set out, the Official Certificates described in Part 1 of the Schedule hereto for the importation from Sweden of meat and meat products as showing:—

(a) that the meat to which they relate, or the meat from which the meat product to which they relate was prepared, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Ministers; and

(b) that the dressing, packing and other preparation of the meat was carried out with all necessary precautions for the prevention of danger to health.

The said Official Certificates are recognised subject to the following conditions:—

- (i) Recognition applies only to meat and meat products imported from Sweden.
- (ii) Where the Official Certificates are in the form of labels, recognition will apply only if the labels are securely affixed to the meat or the meat product and the package containing the meat or meat product, and if the labels have not in any other circumstances or on any other occasion been used as Official Certificates.
- (iii) Where the Official Certificates are in the form of stamps, recognition will apply only if the stamps are clearly impressed or otherwise marked on the meat or the meat products and the package containing the meat or meat product.
- (iv) Recognition of the Official Certificates is restricted to the extent indicated in Parts 2, 3 and 4 of the Schedule hereto.

The Notices published in the *London Gazette* dated 14th March 1978 and 28th October 1982 are hereby revoked.

SCHEDULE

- (a) For meat, the Official Certificate shall consist of a stamp or label bearing the following details within an oval surround 6.5 cm wide by 4.5 cm high:—

on the upper part:

the name SVERIGE in capitals or, if appropriate the set of initials approved for that country under the International Convention on Motor Vehicle Registration, viz: S.

in the centre:

the number of the establishment, which shall be one of those listed in Part 2 of this Schedule.

The letters must be 0.8 cm high and the figures 1 cm high. The seal may include an indication of the official Veterinarian who carried out the health inspection of the meat.

(b) For meat or meat products including canned meat but excluding meat products derived in whole or in part from poultry meat.

A label or stamp in the form below:—

The certificate will be completed by the insertion of the establishment number which shall be one of those listed in Part 3 or 4 of this Schedule.
