TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 209 and 211 of the above Act entitled "The Middlesbrough Northern Route Stage II Road Scheme (Stopping Up) Order 1983" authorising the stopping up of lengths of Boundary Road, Alfred Street, Crown Street, Thompson Street, Linthorpe Road, Brunswick Street, Wilson Street, Marton Road and 3 unnamed highways all at Middlesbrough, Cleveland and requiring the provision of a new road known as Middlesbrough Northern Route Stage II and the provision of new highways in connection with the stopping up of the above highways, such lengths of highway to be highways maintainable at the public expense, for which the highway authority is to be the Cleveland County Council.

The Order also requires the improvement of Boundary Road, Wilson Street, Brunswick Street and Marton Road.
