- (c) to create a new bridleway in the Parish of Bradwell, 6 feet wide and shown by a green line on the map starting from a point on the parish boundary marked "D" approximately 113 metres north-west of point "B" and running in a generally west-south-westerly direction for a distance of approximately 1,031 metres to a point marked "F" on the map, and then in a southerly direction for a distance of approximately 70 metres to its junction with Bridleway No. 4 at the point marked "C" on the map, and
- (d) bridges will be provided on the bridleway at the points marked "X" and "Y" on the map.

A copy of the confirmed Order and the map contained in it has been deposited and may be inspected free of charge at the office of the Borough Secretary, Town Hall, Great Yarmouth, during normal office hours.

This Order becomes operative as from 19th May 1983 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act 1980, or on the grounds that any requirement of that Act, or of any regulation made thereunder has not been complied with in relation to the Order, he may under paragraph 2 of Schedule 2 of the Act as applied by paragraph 5 of Schedule 6 of the Act, within 6 weeks from 13th April 1983 make an application for the purpose to the High Court.
