KENSINGTON AND CHELSEA ROYAL  
BOROUGH COUNCILTOWN AND COUNTRY PLANNING ACT 1971  
TOWN AND COUNTRY AMENITIES ACT 1974

Notice is hereby given that the Council of the Royal Borough of Kensington and Chelsea by resolutions passed on 16th March 1983, designated as a Conservation Area, the area described in Schedule 1 to this notice and as extensions to Conservation Areas, the areas described in Schedules 2-6 to this notice in accordance with the provisions of section 277 of the Town and Country Planning Act 1971.

The effect of designating an area as a Conservation Area is to preserve or enhance its character and appearance.

The demolition of all buildings is brought under control. Anyone wishing to demolish a building within a Conservation Area must first apply for Listed Building Consent to the Local Planning Authority for permission to do so.

In addition, anyone wishing to carry out work to any tree exceeding 75mm diameter in a Conservation Area (other than a tree which is the subject of a Tree Preservation Order) must give notice of their intention to the council at least 6 weeks before the works are due to be executed.
