Notice is hereby given that Her Majesty was pleased on the 22nd June 1983 by Orders in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Marshfield with Cold Ashton; and Tormarton with West Littleton, in the diocese of Bristol.

Uniting the benefices of St. Mary, North Eling; and Minstead, in the diocese of Winchester.

3. Declaring redundant the church of Christ Church, Downside, in the diocese of Bath and Wells.

4. Creating a new benefice and parish of Canwell, and holding in plurality the said new benefice with those of Fazeley; Drayton Bassett; and Hints, in the diocese of Lichfield.

5. Uniting the benefices of Chaddesley Corbett; and Stone, in the diocese of Worcester.

6. Substituting the church of St. David, Moreton-in-Marsh as parish church of the parish of Moreton-in-Marsh with Batsford; and uniting the benefices of Moreton-in-Marsh with Batsford; and Todenham with Lower Lemington, in the diocese of Gloucester.

7. Establishing a team ministry for the area of the benefice of Dovercourt, and altering the areas of the parishes of Ramsey with Little Oakley; and Dovercourt, in the diocese of Chelmsford.

8. (1) Creating a new benefice of Coxley;

(2) uniting the benefices of Coxley; and Wookey with Henton; and

(3) altering the names of the benefice of St. Cuthbert, Wells, with Coxley and Wookey Hole, in the diocese of Bath and Wells.

9. Uniting the parishes of Seavington St. Michael, and Seavington St. Mary, in the diocese of Bath and Wells, and declaring redundant the parish church of Seavington St. Marv.

10. Uniting the benefices of Llanyblodwel and Trefonen, in the diocese of Lichfield.

11. Uniting the benefices of Crewe and Haslington, in the diocese of Chester.

12. Altering the areas of the parishes of Binstead, in the diocese of Winchester and Frensham, in the diocese of Guildford.

13. Creating a new benefice and parish of Deepcar, in the diocese of Sheffield.

14. Declaring reundant the church of St. Mary, Sandwich, in the diocese of Canterbury.

15. Uniting the benefices of Whorlton and Barnard Castle, in the diocese of Durham.

16. Uniting the parishes of Avon Dassett; and Fenny Compton, in the diocese of Coventry, and declaring re-dundant the parish church of Avon Dassett.

17. (1) Substituting St. George's Church, Brighton, as the parish church of St. Anne, Brighton;

(2) Declaring redundant the existing parish church ;

(3) Dissolving the benefice of St. Anne, Brighton ;

(4) Creating a new benefice of St. George and St. Anne Brighton; and
