THE BUILDING SOCIETIES ACT (NORTHERN IRELAND) 1967

*The Building Societies (Authorised Banks) (No. 18) Order
(Northern Ireland) 1983*

The Registrar of Building Societies, with the consent of the Department of Economic Development, in exercise of the powers conferred upon him by section 59 of the Building Societies Act (Northern Ireland) 1967, hereby makes the following Order:

- (1) The Building Societies (Authorised Banks) Order (Northern Ireland) 1975 is hereby varied by—The change of name in paragraph 1 thereof of Midland and International Banks Limited to MAIBL PLC; and Gerrard and National Discount Company Limited to Gerrard & National PLC.
- (2) The Building Societies (Authorised Banks) (No. 9) Order (Northern Ireland) 1980 is hereby varied by the change of name in paragraph 1 thereof of The National Bank of Australasia Limited to National Commercial Banking Corporation of Australia Limited.

- (3) The Building Societies (Authorised Banks) (No. 12) Order (Northern Ireland) 1981 is hereby varied by the deletion in paragraph 1 thereof of The Commercial Banking Company of Sydney, Limited.

- (4) This Order may be cited as the Building Societies (Authorised Banks) (No. 18) Order (Northern Ireland) 1983.

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under S.209 of the above Act entitled "The Stopping Up of Highways (County of South Yorkshire) (Sheffield No. 11) Order 1983", authorising the stopping up of a length of Richards Road, Heeley Green, Sheffield.
