BERKSHIRE COUNTY COUNCIL

Royal County of Berkshire (Various Roads, Crowthorne)
(Prohibition and Restrictions of Waiting) Order 1983

Notice is hereby given that the Berkshire County Council have made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to:

- (1) Prohibit any vehicle from waiting during the hours of 7 a.m. and 7 p.m. Monday to Saturday inclusive in the lengths of road specified in Schedule 1 to this notice.
- (2) Restrict waiting to half an hour, return prohibited within $\frac{1}{2}$ hour on Monday to Saturday 8 a.m. to 6 p.m. inclusive in the length of road specified in Schedule 2 to this notice.

The usual exemptions for loading, unloading, disabled drivers etc. are included in the Order.

The Order will come into operation on 11th July 1983.

Copies of the Order and relevant map can be inspected during normal office hours at the offices of the Bracknell District Council, Easthampstead House, Town Square, Bracknell, and at the County Secretary's Department at the address given below.

Royal County of Berkshire (Waterloo Road and Rances Lane, Wokingham) (Prohibition of Waiting) Order 1983

Notice is hereby given that the Berkshire County Council have made an Order under section 1 and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to:

- (1) Revoke the Royal County of Berkshire (Rances Lane/Waterloo Road, Wokingham) Prohibition of Waiting Orders 1975.
- (2) Prohibit Waiting in the lengths of road specified in the Schedule to this notice.

Prohibition of Waiting at any Time

Rances Lane

Eastern side, northwards for a distance of approximately 11 metres from its junction with Waterloo Road.

Western side, northwards for a distance of approximately 50 metres from its junction with Waterloo Road.

Waterloo Road

Northern side, from its junction with Easthampstead Road north-eastwards for a distance of approximately 315 metres.

Southern Side:

(i) from its junction with Easthampstead Road north-eastwards for a distance of approximately 47 metres;
