The Trunk Road (A453) (Hollow Way, Tamworth) (Prohibition and Restriction of Waiting) (Experimental) Order 1983.

The Secretary of State for Transport hereby gives notice that he has made an Order under section 9 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, and by Schedule 6 to the Road Traffic Act 1974, on the north-east of Birmingham—Nottingham Trunk Road (A453) at Hollow Way, Tamworth in the District of Tamworth in the County of Staffordshire.

The effect of the Order, which will come into operation on Monday, 25th July 1983, and will continue in force for a period not exceeding 18 months, will be to restrict waiting on the east side of Hollow Way, Tamworth as follows:

- (1) Waiting will be prohibited at all times on those lengths commencing:
 - (a) at a point 93 metres south of the centre line of Market Street southwards for a distance of 22 metres;
 - (b) at a point 37 metres south of the centre line of Market Street southwards for a distance of 5.4 metres.
- (2) Waiting will be limited to 20 minutes in any hour and no return within 2 hours, from 8 a.m. to 6 p.m. on Mondays to Saturdays on that length commencing at a point 42.4 metres south of the centre line of Market Street southwards for a distance of 50.6 metres.

This will improve the amenities of the area by providing greater provision for casual visitors requiring short-term parking. Adequate alternative facilities are available for long stay vehicles at present parking on the trunk road.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building, industrial or demolition operations, the removal of any obstruction to traffic or the maintenance of the road or the services therein.
