NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To: Kabiru Nasiru & Co., 360A Airport Road, Box 1403, Kano, Nigeria.

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Act, certain goods, namely:

178 sacks of gum arabic

imported into the United Kingdom by you on or about 7th January 1983, at Gatwick Airport, Sussex, have been seized as liable to forfeiture upon the ground(s) that:

- (i) the said sacks contained a substance the importation of which is prohibited, namely a quantity of cannabis. The gum arabic was mixed, packed and found with the said cannabis;
- (ii) the said sacks of gum arabic had been used for the concealment of the said cannabis.

Whereby and by force of section 141 49 (1) (b) of the Customs and Excise Management Act 1979 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a Solicitor in England and Wales who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
