NOTICE OF SEIZURE UNDER THE OUSTOMS AND EXCISE MANAGEMENT ACT 1979

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely:

1 gas pistol

2 gas cartridges

have been seized as liable to forfeiture upon the ground(s) that the said goods were imported into the United Kingdom at Dover on or about 7th March 1982, contrary to the prohibition imposed by the Import of Goods (Control) Order 1954, made under the Import Export and Customs Powers (Defence) Act 1939, section 1

Further or in the alternative the said goods were

imported in contravention of the restriction imposed by section 40 (9) of the Explosives Act 1875.

Whereby and by force of section 49 (1) of the Customs and Excise Management Act 1979, the said goods are liable
