BLABY DISTRICT COUNCIL

CLEAN AIR ACTS 1956 AND 1968, AS AMENDED

The Blaby District Council (Narborough, Littlethorpe and St. Johns) Smoke Control Order (No. 16) 1983

Notice is hereby given that the Blaby District Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, as amended, propose to make

an Order entitled "The Blaby District Council (Narborough, Littlethorpe and St. Johns) Smoke Control Order (No. 16), 1983" declaring the area described in the Schedule hereto to be a smoke control area.

Subject to the exceptions provided by the proposed Order and by virtue of section 11 (4) of the 1956 Act if, on any day after the Order comes into operation smoke is emitted from a chimney or any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Subject to the provisions of section 9 of the Clean Air Act 1968, any person who acquires for use in a smoke control area or who sells by retail for delivery in a smoke control area any solid fuel other than authorised fuel shall be guilty of an offence and liable to a fine not exceeding £100.

If made the Order will come into operation on 1st November 1984 or a later date determined by the Council.

AVON COUNTY COUNCIL

Exemptions will be provided in the Order for any vehicle to enter, proceed or wait in the bus lane for the removal of any obstruction to traffic; police, fire brigade or ambulance purposes in an emergency; in avoidance of an accident; access to or egress from off-street loading or garaging; the pursuance of statutory powers or duties or in connection with the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878; and the boarding or alighting only of any disabled person from a disabled person's vehicle displaying a disabled person's badge in the relevant position.

- (2) County Council of Avon (Ashley Road, City Road, Lower Ashley Road and Mina Road Park Area, Bristol) (Prohibition and Restriction of Waiting) (One Way Traffic) (Variation) (No. 2) Order 198 under section 1 (1), (2), (3) and 84D (1) of the said Act the effect of which will be to vary further the County Council of Avon (Ashley Road, City Road, Lower Ashley Road and Mina Road Park Area, Bristol) (Prohibition and Restriction of Waiting) (One-Way Traffic) Order 1979 so as to:

- (1) prohibit any vehicle waiting between the hours of 8 a.m. and 6 p.m., Monday to Saturday, subject to specified exemptions, in the lengths and sides of roads specified in Schedule 2 to this notice;

- (2) impose one-way traffic working in the length of road specified in Column 1 of Schedule 3 to this notice in the direction specified in relation to that length of road in Column 2 of the said Schedule;

- (3) prohibit any vehicle proceeding along the length of road specified in Column 1 of Schedule 4 to this notice, from making a right turn into the length of road specified in Column 2 of Schedule 4 to this notice.

AVON COUNTY COUNCIL

County of Avon (Various Roads, Durdham Down Area, Bristol) (Weight Restriction) Order 1983

Slip road from Spondon Island to the west-bound carriageway of Borrowwash Bypass extension, from its junction with Spondon Island for a distance of 40 metres in a south-westerly direction.

Nottingham Road, Chaddesden, from a point 100.6 metres east of its junction with Lyndhurst Grove to its junction with Raynesway.

The parking facilities available in this area will thus be slightly redistributed, but the net space available remains unchanged.

ROAD TRAFFIC REGULATION ACT 1967

Notice is hereby given that Cambridge City Council acting as agent for Cambridgeshire County Council pursuant to section 101 of the Local Government Act 1972 and in exercise of the powers of the said County Council under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, intend making the following Orders:

This Order will prohibit motor vehicles from entering Burleigh Place from Crispin Place except for access.

(5) *The City of Cambridge (Severn Place|Fitzroy Street) (Prohibition of Entry) Order 1983.*

This Order will prohibit motor vehicles from entering Severn Place from Fitzroy Street except for access.
