The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act 1971, to authorise the stopping up of the highway described in the Schedule to this notice to enable development to be carried out.

The proposed Order requires the provision of new footpaths, which will be highways maintainable at the public expense, and for which Mid Glamorgan County Council shall be the highway authority.

During 28 days from 22nd September 1983, copies of the draft Order and the relevant plan may be inspected free of charge at all reasonable hours at the offices of the Ogwr Borough Council, Municipal Buildings, The Rhiw, Bridgend.

Within the above-mentioned period of 28 days, any person may by notice to the Secretary of State, Welsh Office, Transport and Highways Group, Government Build-ings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting ref. TRPC 15/5/2); object to the making of the Order, other the ground for objection stating the grounds for objection.

The highways to be stopped up are at Bridgend in the borough of Ogwr in the county of Mid Glamorgan, and are lengths of highway which extend from:

(a) its junction with Tremains Road in a general southeasterly direction for a distance of 33 metres; and

(b) its junction with the un-named access road leading to the servicing garage at Tremains Road, in a general northerly direction for a distance of 54 metres. (2 SD
