Exemptions to the proposed Order will permit the following:

- (a) in relation to items (1) and (2) above use by emergency vehicles (fire brigade, police, ambulance)
- (b) in relation to items (3) and (4) above for the conveyance of persons or goods; agriculture; to enable works to be carried out; in pursuance of statutory powers or duties; within the area or adjacent to the roads specified in Column 3 of each of the Schedules A and B.

A copy of the proposed Order and a map showing the lengths of road referred to, with a copy of the Statement of Reasons for proposing to make the Order may be inspected at County Hall, Aylesbury during normal office hours and at Stony Stratford Library, 5-7 Church Street, Stony Stratford during normal opening hours.
