ROAD TRAFFIC REGULATION ACT 1967: SECTION 1

The Trunk Road (A523) London Road South, Poynton (Prohibition of Waiting) Order 1983

Notice is hereby given that the Secretary of State for Transport has made an Order under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974 on the Derby-Macclesfield-South of Stockport Trunk Road (A523), known as London Road South at Poynton, in the Borough of Macclesfield in the County of Cherchief Cheshire.

The effect of the Order will be to prohibit waiting at any time on any day on the side trunk of road specified in the Schedule to this notice.

Exceptions will be provided in the Order to enable a person to board or alight from a vehicle; to enable goods to be loaded on to or unloaded from a vehicle; to enable a vehicle to be used in connection with any building, industrial or demolition operations connection with any building, industrial or demonston operations to enable the removal of any obstruction to traffic or the mainten-ance of the road or the service therein; to enable a vehicle to be used for the purpose of delivering or collection postal packet; or to enable a disabled person's vehicle to wait for up to two hours. Any person who desires to question the validity of, or of any provision contained in the Order, on the ground that it is not within the powers with respect to the Order conferred by the above

Act, or on the grounds that any requirement of, or of any instrument made under any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of the 28th October 1983 apply to the High Court for the suspension or

quashing of the Order or of any provision contained therein. London Road South (East Side)-from a point 20 metres (21.6 yards) north of its junction with Queensway to a point 15 metres (16.4 yards) south of its junction with Queensway. (14 SI)

Wildlife and Countryside Act 1981, Section 16 Licence to Kill or Take Bullfinches (BIR/GEN/1)

Notice is hereby given that, as provided by Section 16 of the Wildlife and Countryside Act 1981, the Minister of Agriculture, Fisheries and Food has with effect from 28th September 1983, issued a conditional General Licence (BIR/GEN/1) for authorised persons to kill bullfinches, or to take them using a cage trap, within the areas specified in the Schedule to the Licence for the purpose of preventing serious damage to the buds of fruit trees and fruit

bushes within those areas. In the Licence "authorised persons" means any fruit grower who is the owner or occupier, or any person authorised by such an owner or occupier, of the land on which the action authorised is taken.

The Licence is subject to the following conditions

(i) Unless previously revoked, it shall expire on 27th September 1985:

- (ii) any Bullfinches killed under the authority of the Licence shall be killed quickly and humanely but no method of killing may be used which is prohibited by Section 5 of the Wildlife and Countryside Act 1981:
- (iii) every cage trap used under the authority of the Licence shall be inspected by an authorised person at least twice a day, including an inspection at dusk, when the cage trap is in use. At each inspection, any birds caught in the trap shall be removed from it and those birds (other than bullfinches) which cannot be identified with certainty as being included in Part II of Schedule 2 to the Wildlife and Countryside Act 1981 shall immediately be released and all necessary precautions shall be taken at the time of their release to prevent injury to them; (iv) no birds shall be allowed to remain in a cage trap overnight.
