

goods to be loaded onto or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, or in the service of a local authority or a water authority or for the purposes of the police, ambulance or fire services, the removal of any obstruction to traffic, maintenance of the road or services therein. Exceptions have also been provided for disabled persons' badge holders and for a vehicle waiting upon the direction or with the permission of a police constable in uniform or of a traffic warden.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 18th October

1983, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

ROAD TRAFFIC ACTS

AVON COUNTY COUNCIL

Various Traffic Orders, City of Bath

Notice is hereby given that the County Council of Avon propose to make the following Orders under provisions contained in the Road Traffic Regulation Act 1967, as amended:

(1) County Council of Avon (City of Bath) (Outer Areas) (General Traffic Regulation) (Variation No. 11) Order 198 , under sections 1 and 84D (1) of the said Act the effect of which is to vary further The City of Bath (Outer Areas) (General Traffic Regulation) Order 1971 so as to re-introduce two way traffic working along that length of Osborne Road which extends from a point 50 metres south-west of Avondale Road to its junction with Brassmill Lane.

(2) County Council of Avon (Osborne Road and Avondale Road, Bath) (Prohibition of Heavy Commercial Vehicles of over 7.5 tonnes Maximum Gross Weight) Order 198 , under section 1 of the said Act the effect of which is to prohibit any heavy commercial vehicle, the maximum gross weight of which exceeds 7.5 tonnes, from proceeding along the lengths of road specified in Schedule 1 to this notice.

Exemptions are provided in the Order for any heavy commercial vehicle to be used for the conveyance of goods to or from any premises situated on or adjacent to the road; in connection with statutory powers or duties, building operations, agriculture, forestry, the maintenance of the road or services therein; for the removal of obstruction to traffic; fire brigade, police or ambulance purposes; the conveyance of goods for sale from the vehicle and for the garaging, servicing or carrying out of repairs to the vehicle.

(3) County Council of Avon (Osborne Road, Bath) (Width Restriction) Order 198 , under section 1 of the said Act the effect of which is to prohibit any vehicle the width of which, inclusive of any load on the vehicle, exceeds 6 feet 6 inches to proceed in the length of road specified in Schedule 2 to this notice.
