

Conditions attached to Licence A.

(1) Each consignment must be accompanied by a certificate signed by a duly authorised Veterinary Officer of the Government of the exporting country stating that:

- (a) the meat/offal is derived from animals slaughtered in an abattoir licensed for the production of meat for human consumption;
- (b) the meat/offal is derived from animals which received veterinary ante and post-mortem inspection by an official veterinary surgeon and showed no evidence of the following diseases:

Foot and mouth disease, tuberculosis, brucellosis, anthrax, rabies, African swine fever, classical swine fever (hog cholera), swine vesicular disease and Teschen disease.

- (c) the meat offal has been obtained from animals that have been resident in the country of origin for at least 3 months prior to slaughter or since the birth in the case of animals less than three months old.
- (d) the meat/offal has not been obtained from animals which come from a holding or area which for health reasons is under restriction for any of the diseases mentioned in (1) (b).
- (e) the meat/offal has not been obtained from a slaughterhouse which is under restriction as a result of foot and mouth disease.
- (f) no vaccine against swine fever containing a live or attenuated swine fever virus has been used in the country of origin during the (previous) 12 months.
- (g) there has been no outbreak of swine fever in the country of origin during the (previous) 12 months.

(2) The meat/offal must be transported in sealed containers which bear a mark to the effect that the meat/offal is not intended for human consumption.

(3) Any meat imported under this licence shall be made available if so required for inspection and/or sampling by an officer of the Ministry at any place nominated by him for such inspection and/or sampling. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection and/or sampling in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection and/or sampling.

Subject: Meat/offal of ruminating animals (not intended for human consumption).

Countries: United States of America, Canada, Finland, Sweden, Norway, Iceland.

- (b) as 1A above—in Wales.

Conditions attached to Licence B.

(1) Each consignment must be accompanied by a certificate signed by a fully authorised veterinary officer of the Government of the exporting country stating that:

- (a) the meat/offal is derived from animals slaughtered in an abattoir licensed for the production of meat for human consumption.
- (b) the meat/offal is derived from animals which received veterinary ante and post-mortem inspection by an official veterinary surgeon and showed no evidence of the following diseases:

Foot and mouth disease, tuberculosis, brucellosis, anthrax, cattle plague, bovine pleuro-pneumonia, enzootic bovine leukosis and rabies.

- (c) the meat/offal has been obtained from animals that have been resident in the country or origin for at least 3 months prior to slaughter or since birth in the case of animals less than 3 months old.
- (d) the meat/offal has not been obtained from animals which come from a holding or area which for health reasons is under restriction for any of the diseases mentioned in (1) (b).
- (e) the meat/offal has not been obtained from a slaughterhouse which is under restriction as a result of foot and mouth disease.

(2) The meat/offal must be transported in sealed containers which bear a mark to the effect that the meat/offal is not intended for human consumption.

(3) Any meat imported under this licence shall be made available if so required for inspection and/or sampling

by an officer of the Ministry at any place nominated by him for such inspection and/or sampling. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection and/or sampling in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection and/or sampling.

Subject: Meat/offal derived from horse, ass, mule, hinny (not intended for human consumption).

Countries: Argentina, Australia, Austria, Belgium, Botswana, Brazil, Canada, Czechoslovakia, Denmark, Finland, France, Federal Republic of Germany, Hungary, Irish Republic, Isle of Man, Italy, Kenya, Luxembourg, Namibia (South West Africa), Netherlands, New Zealand, Norway, Poland, Romania, South Africa, Swaziland, Sweden, Switzerland, U.S.A., Hungary, Uruguay, Yugoslavia.

Licences are valid through ports:

- *(a) As 1A above—in England.
- (b) As 1A above—in Wales.

Conditions attached to Licence C.

(1) Each consignment must be accompanied by a certificate signed by a duly authorised veterinary officer of the Government of the exporting country stating that:

- (a) the horse meat/offal originated from a slaughterhouse under veterinary supervision and approved by the Government of the exporting country.
- (b) the horse meat/offal contains no admixture of meat or offal from ruminating animals or swine.

(2) The horse meat/offal must be transported in sealed containers which bear a mark to the effect that the horse meat/offal is not intended for human consumption.

(3) Any meat imported under this licence shall be made available if so required for inspection and/or sampling by an officer of the Ministry at any place nominated by him for such inspection and/or sampling. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection and the sampling in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection and/or sampling.

Subject: Meat/offal of ruminating animals and swine (not intended for human consumption).

Countries: Australia and New Zealand.

Licences are valid through:

- *(a) As 1A above—in England.
- (b) As 1A above—in Wales.

Conditions attached to Licence D.

(1) Each consignment must be accompanied by a certificate signed by an authorised veterinary officer of the Government of Australia/New Zealand as appropriate stating:

- (a) the meat/offal has been produced in a licensed abattoir.
- (b) the meat/offal was derived from animals which received veterinary ante and post-mortem inspection and the meat/offal has been found fit for pet food in accordance with the Australia/New Zealand requirements.
- (c) all animals slaughtered for export to Great Britain originated in Australia/New Zealand as appropriate.
- (d) there has been no outbreak of foot and mouth disease or swine fever in Australia/New Zealand during the previous 12 months.
- (e) In the case of pig meat no vaccine against swine fever containing a live or attenuated swine fever virus has been used in Australia/New Zealand during the 12 months, prior to slaughter.

(2) The meat/offal must be transported in sealed containers, which bear a mark to the effect that the meat/offal is not intended for human consumption.

(3) Any meat imported under this licence shall be made available if so required for inspection and/or sampling by an officer of the Ministry at any place nominated by him for such inspection and/or sampling. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection and/or sampling in such manner as he shall determine and the importer shall
