The Order also provides for the closure of the 2 existing gaps in the central reservation opposite the junctions of Pound Road (east and west) with the trunk road which at present form part of a staggered junction. The road at this junction has been realigned and a new gap in the central reservation has been provided to allow vehicles to travel between the two sections of Pound Road via a traffic signal controlled crossing.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any Instrument made under, any provision of that Act has not been complied with in relation to the Order may ,within 6 weeks og 9th January 1984 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
