### WELSH OFFICE

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of the highway described in the Schedule to this notice to enable development to be carried out.

During 28 days from 12th January 1984, copies of the draft Order and the relevant plan may be inspected free of charge, at all reasonable hours at the offices of Cynon Valley Borough Council, at Rock Grounds, High Street, Aberdare.

The highway to be stopped up is at Mountain Ash in the Borough of Cynon Valley in the county of Mid Glamorgan and is that length of Cardiff Road which extends from a point 5 yards from the nearest point to the junction with New Road (A4059) in a general north-westerly direction for a distance of approximately 22 yards.
