CERTIFICATES OF TAX DEPOSIT (SERIES 6)

On and after 28th February 1984, the rates of interest applicable to deposits accepted under the Prospectus (Series 6) dated 11th October 1982, will be as follows:

(a) for deposits of £100,000 or over:

Under 1 month	9½ per cent	7½ per cent
1 but less than 3 months ...	9½ per cent	7½ per cent
3 but less than 6 months ...	9½ per cent	7½ per cent
6 to 12 months	10 per cent	7½ per cent

in the relevant year of the interest period

(b) for deposits of less than £100,000: 9½ per cent if the deposit is applied in payment of a scheduled liability and 7½ per cent if the deposit is withdrawn for cash.

For deposits made under earlier Prospectuses (Series 4 and 5) which reach the second or fourth anniversary of the deposits, as applicable, in accordance with the terms and conditions set out therein: 10 per cent if the deposit is applied in payment of a scheduled liability, and 7½ per cent if the deposit is withdrawn for cash.

These rates will remain in force until further notice.

TOWN AND COUNTRY PLANNING ACT 1971

Proposed Stopping Up of Part of Avon Street and a Nearby Passage in Oldham

The Secretary of State for Transport hereby gives notice that on the application of Oldham Borough Council he has made an Order under section 209 of the above Act entitled "The Stopping up of Highways (County of Greater Manchester) (No. 1) Order 1984" authorising the stopping up of part of Avon Street and a nearby passage in Oldham.

Copies of the Order may be obtained, free of charge, on application to the office of the Director (Transport), Departments of the Environment and Transport, North West Region, Sunley Building, Piccadilly Plaza, Manchester M1 4BE (quoting ref. NWRT 5035/41/106), and may be inspected at all reasonable hours at the offices of the Director of Legal Services, Civic Centre, West Street, Oldham.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 5th March 1984, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
