TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping-up of an area of un-named highway situated between the A31 Romsey Road and Old Romsey Road fronting the White Hart Public House at Cadnam in the District of New Forest in the County of Hampshire. This is to enable an extension to the White Hart Public House to be carried out in accordance with planning permission granted by New Forest District Council under Part III of the said Act.

During 28 days from 26th March 1984 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the New Forest District Council Offices, Appletree Court, Lyndhurst, Hampshire and may be obtained free of charge from the Secretary of State (quoting ref. DSE 5057/35/1/L/023) at the address stated below.

Within the above-mentioned period 28 days, any person may by notice to the Secretary of State for Transport (ref. DSE 5057/35/1/L/023), at his address of the Director (Transport), Departments of the Environment and Transport, South East Regional Office, 74 Epsom Road, Guildford, Surrey GU1 2BL, object to the making of the Order.

THE IMPORTED FOOD REGULATIONS 1968, AS AMENDED

Hungary: Official Certificate

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales acting jointly in exercise of the powers conferred on them by the Imported Food Regulations 1968 (S.I. 1968 No. 97), as amended by the Imported Food (Amendment) Regulations 1973, 1979 and 1981 (S.I.

1973, No. 1351, S.I., 1979 No. 1426 and S.I. 1981, No. 1085) gives notice that they hereby restrict recognition of the Official Certificates reproduced in the Schedule to the notice published in the *London Gazette* dated 9th March 1983 for the importation of meat and meat products from Hungary, to the extent shown in the Schedule hereto.

The notice published in the *London Gazette* dated 24th June 1983 is hereby revoked.
