#### THE TRUNK ROAD (A487) (LOWER TOWN, FISHGUARD, DYFED) (RESTRICTED ROADS) ORDER 1984

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 72 and 73 of the Road Traffic Regulation Act 1967, as amended which shall come into operation on 2nd May 1984. The effect of the Order will be to prohibit the driving of motor vehicles at a speed exceeding 30 miles per hour in the length of road specified in the Schedule to this Notice.

A copy of the Order, together with a plan and statement of reasons for making the Order, may be seen during normal office hours at the offices of the Dyfed County Council, Area Surveyor's Office, High Street, Fishguard during a period of six weeks from 23rd March 1984.
