HARBOURS ACT 1964

THE PROPOSED PORT OF SUNDERLAND HARBOUR REVISION ORDER

Notice is hereby given that a Public Local Inquiry in connection with the above proposed Order will be held by Mr. D. M. Sims (a person appointed by the Secretary of State for that purpose) at Committee Room 1, Civic Centre, Sunderland on Tuesday, 31st July 1984 at 10.30 a.m. when representations from persons who have objected to the draft Order, and from any other persons who desire to appear, will be heard.

The proposed Order, which has been applied for by Sunderland Borough Council under section 14 of the above Act, provides for the making of certain amendments to the byelaw making powers contained in sections 63, 64 and 65 of the

Sunderland Corporation Act 1972 which will have the effect of giving authorised officers of the Council certain powers previously held by the harbour master and of increasing the maximum penalty for contravention of byelaws made thereunder to £200.
