If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any Instruments made under it has not been complied with in relation to the Order, you may, within the aforesaid period of 6 weeks, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The south side of that length of the Fishguard-Bangor Trunk Road (A487) known as Dublin Street at Tremadog in the County of Gwynedd which extends from a point 29 metres east of its junction with Sunnyside in a general north-easterly direction as far as Market Square being a distance of 50 metres.
