The Trunk Road (A487) (Porthmadog, Gwynedd) (Prohibition and Restriction of Waiting) Order 1984

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended.

The effect of the proposed Order will be to prohibit (with certain exceptions) the waiting of any vehicle, between the hours of 8 a.m. and 7 p.m. on any day, for more than 1 hour in any period of 3 hours, in that length of and those sides of the Fishguard-Bangor Trunk Road (A487) hereinafter referred to as "the trunk road" specified in the Schedule to this notice.

The usual exceptions are also provided for vehicles displaying a disabled person's badge in accordance with the Orange Badge Scheme.

A draft Order, a copy of the Order being revoked, together with a plan and statement of reasons for making the Order, may be inspected during normal office hours at the offices of Dwyfor District Council, Pwllheli, Gwynedd.
