Designation of Conservation Areas

Notice is hereby given that Torfaen Borough Council as Local Planning Authority in pursuance of the powers conferred upon it by section 277 of the Town and Country Planning Act 1971, as amended, has designated the following as Conservation Areas:

(1) Blaenavon Town Centre Conservation Area.
(2) Cwmavon Conservation Area.
(3) Pontypool Town Centre Conservation Area.
(4) Upper Cwmbran Conservation Area.

(5) Llantarnam Conservation Area.

The purpose of such designations is to preserve and enhance the character and appearance of areas of special architectural or historic interest.

The Local Planning Authority is required to prepare and publish specific policies for these areas and to exercise control over development in them.

The main effect of designating these Conservation Areas

- (a) Applications for Listed Building Consent to demolish certain buildings must be made to and approved by the Local Planning Authority before any demolition takes place;
- (b) Any person wishing to fell, lop or top trees must give 6 weeks notice to the Local Planning Authority; (c) Conservation areas may also be considered as possible areas of special control for the display of advertisements;
- (d) The Local Planning Authority will be preparing conservation policies for the enhancement of its conservation areas.

## SCHEDULE

Brief Description of the Designated Conservation Areas

- 1. Blaenavon Town Centre: The designated area includes the whole of the historic urban centre between Broad Street, Church Road, Castle Street and the Blaenavon Ironworks site.
- 2. Cwmavon: The designated area is centred on Shop Road and Cwmavon Road, and includes the area, between the high level railway line, Rose Cottages, Cwmavon Works, Forge Row and the Red House.
- 3. Pontypool Town Centre: The designated boundary covers the main central area, and includes the Valley Inheritance Museum and St. Albans School, together with the properties on Clarence Street, Hanbury Road, Lower Bridge Street, St. James Field, Commercial Street, Market Street and part of Osborne Road and George Street.
- 4. Upper Cwmbran: The designated boundary is based on The Square and includes the area of former mine workings at the Mine Slope, the Siloam Chapel, Glyn Bran, Whittakers Row, the Bush Inn and the area immediate to Graig View and the Bethel Chapel.
- 5. Llantamam: The designated boundary includes the area between Llantarnam Abbey and Abbey Farm and Cottages, together with St. Michaels Church, the Greenhouse and Brook House, and also the Magna Porta Lodge. (733)
