HIGHWAYS ACT 1980

The east of Birmingham—Birkenhead Trunk Road (A41) (Tong) and the Worcester—Wolverhampton—South of Stafford Trunk Road (A449) (Coven Heath) Trunking Order 1981

The Secretary of State for Transport hereby gives notice that he has made an Order under section 10 and 12 of the Highways Act 1980 the effect of which is to provide:

(a) that the length of highway for a distance of approximately 0.54 of a kilometre (0.33 of a mile) forming the roundabout at the junction of the A41 trunk road with the M54 Motorway at Tong in the county of Shropshire and marked 'A' on the deposited plan 1 and

(b) that the length of highway for a distance of approximately 0.54 of a kilometre (0.33 of a mile) forming the roundabout at the junction of the A449 trunk road with the M54 Motorway at Coven Heath in the county of Staffordshire and marked 'B' on the deposited plan 2

shall become trunk roads as from the date on which the Secretary of State for Transport notifies the County Councils of Shropshire and Staffordshire that the above mentioned Order comes into operation.
