ROAD TRAFFIC REGULATION ACT 1984

For the purposes of section 17 (5) and of all other relevant provisions of the above Act The Secretary of State for Wales hereby gives notice in accordance with the Special Roads (Notice of Opening) Regulations 1962 that 7th December 1984 will be the date on which the special roads described in the Schedule hereto are open for use as special roads.

SCHEDULE

Routes of The Special Roads A55

Llanddulas to The Rhos-on-Sea Interchange (Brompton Avenue)

A route about 6.7 kilometres (4.2 miles) in length starting at a point on the existing Trunk Road (A55) just to the east of its junction with the B5443 road at Llanddulas in the County of Clwyd and proceeding in a general westerly direction ending at the Rhos-on-Sea Interchange in Colwyn Bay in the County of Clwyd.

Routes of the connecting roads

1. Two routes to connect the westbound and eastbound carriageways of the new A55 road with the B5443 road at Llanddulas.

2. Four routes to connect the westbound and eastbound carriageways of the new A55 road with a new link road constructed at Eirias Park, Old Colwyn.

3. Four routes to connect the westbound and eastbound carriageways of the new A55 road with Victoria Avenue constructed near Colwyn Bay Station.

4. A route to connect the westbound carriageway of the new A55 road with Princes Drive (B5104) near its junction with the existing Trunk Road (A55) at the west end of Colwyn Bay.

5. A route to connect the eastbound carriageway of the new A55 road with Brompton Avenue, Colwyn Bay.
