The general effects of the Hackney and Tower Hamlets (Prescribed Routes) (No. 1) Traffic Order 1984 will be, in connection with the creation of a cycle route (known as the Market Porter's Cycle Route) between Hackney Town Hall and Hackney Road via Hackney Grove, Martello Street, London Fields, Market, Broadway Goldsmith's Row and Haggerston Park, to:

(a) revoke and re-enact in a modified form the one-way working for vehicular traffic in Goldsmith's Row, imposed by the London Traffic (Prescribed Routes) (Bethnal Green and Shoreditch) Regulations 1957, so as to exempt pedal cycles in the Goldsmith's Row cycle, (described in sub-paragraph (c) (iv) below) lane from the said one-way working;

(b) revoke and re-enact in a modified form the Hackney (Prescribed Route) Traffic Order 1972, so as to permit market barrows, pedal cycles and vehicles being used for fire brigade, ambulance or police purposes in certain circumstances to proceed through the existing carriageway closure in Broadway Market adjacent to Brougham Road;

(c) prohibit all vehicles from entering or proceeding or waiting in the cycle lanes created:

(i) on the south-east side of Hackney Grove (here-inafter referred to as the "Hackney Grove cycle lane ")

(ii) on the south-east side of Martello Street, between Richmond Road and a point 50 metres north-east of the north-eastern kerb-line of Ellingfort Road (hereinafter referred to as the "Martello Street cycle

lane");
(iii) on the north-west side of the island site at the junction of Broadway Market, Lansdowne Drive and Westgate Street and lying opposite Nos. 81 to 85 inclusive Broadway Market (hereinafter referred to as the "Broadway Market cycle lane");
(iv) on the south-east side of Goldsmith's Row, between Key Street and a point opposite the north-eastern extremity of the Haggerston Park cycle lane, described below (hereinafter referred to as the "Goldsmith's Row cycle lane"):

(vi) on the west side of the highway which lies south of Hackney Road directly oposite the southern extremity of the Haggerstone Park cycle lane which like here to be the Haggerstone Park lies between the southern kerb-line of Hackney Road and a point 12 metres south of that kerb-line (herein-after referred to as the "Columbia Road cycle lane"); The above-mentioned prohibitions will not apply to

pedal cycles entering:

(A) the Broadway Market, Columbia Road, Hackney Grove, Haggerston Park and Martello Street cycle lanes; or cycle lanes; or
(B) the Goldsmith's Row cycle lane at its nor-

therly extremity;

(d) prohibit the left turn by pedal cycles from the Haggerston Park cycle lane into Hackney Road;
