NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To J Barry, 113 Studley Road, Heidelberg 3084, Melbourne, Australia

26th February 1985

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraphs 1 and 2 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give you notice in writing that by virtue of the powers contained in the customs and excise Acts, certain goods, namely

One Volkswagen Combi Van, registration number QT6907, imported into the United Kingdom at a place and on a date unknown, has been seized as liable to forfeiture upon the ground(s) that temporary relief from payment of customs duties chargeable in respect of the said goods was afforded under Part 2 of the Customs Duties (Personal Reliefs) Order 1970, and a condition, *inter alia*, imposed by Article 5 thereof, and subject to which relief was granted, has not been complied with in that the said vehicle was not exported from the United Kingdom within 12 months from the date of its importation

Whereby and by force of section 124 (1) of the Customs and Excise Management Act 1979 and Article 17 of the Customs Duty (Personal Reliefs) Order 1970, the said goods are liable to forfeiture

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of the said Schedule 3 specifying the name and address of a Solicitor in the United Kingdom, who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim, within the time aforesaid, legal proceedings will be taken for the condemnation of the said goods
