Notice is hereby given that, the Greater London Council on 15th April 1985, made the above-mentioned Order under section 9 of the Road Traffic Regulation Act 1984 2 The general effect of the Order will be

- (a) to suspend the designation by the City of Westminster (Parking Places) (No 22) Order 1976, of the parking place numbered 235 therein and by the City of Westminster (Parking Places) (Amendment No 2) Order 1984, of the parking place numbered 434 therein which parking places are situated on the south-east side of Victoria Embankment between Cleopatra's Needle and Horseguards Avenue,
- (b) to designate a metered parking place on the southeast side of Victoria Embankment between Cleopatra's Needle and Embankment Station at which the rate Needle and Embankment Station at which the rate of charge will be 10p for 10 minutes (maximum initial period 2 hours) This parking place will operate between 10 a m and 6 30 p m on Mondays to Fridays inclusive and between 8 30 a m and 1 30 p m on Saturdays Waiting by vehicles in the parking place will be prohibited between 8 a m and 10 a m on Mondays to Fridays, however coaches will be allowed to set down passengers during those hours in the parking place The meters in the parking place will be painted white.
- (c) to designate two metered parking places on the south-east side of Victoria Embankment between Northumberland Avenue and Horseguards Avenue at which the rate of charge will be 10p for 15 minutes (one with a maximum initial period 2 hours and one with a maximum initial period of 4 hours) These parking places will operate between hours) These parking places will operate between 8 30 a m and 6 30 p m on Mondays to Fridays inclusive and between 8 30 a m and 1 30 p m on Saturdays.
- (d) to provide in respect of all metered parking places that
 - (i) the excess charge—payable to the Westminster City Council—will be £8, the excess period will be I hour, the unexpired time on a meter may be used free of charge and the period during which a vehicle may not return to a parking place will be 1 hour, and

(11) the vehicles which may be left in a parking place shall be passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles and invalid carriages,

(iii) that certain vehicles may wait, free of charge, in certain circumstances e.g., to allow persons to board or alight (maximum 2 minutes) to load or unload (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit)
