- (a) the construction of a main new trunk road about 749 kilometres (465 miles) in length starting on the proposed Rochester Way Relief Road at Falconwood in the London Borough of Greenwich, about 350 metres (383 yards) west of Rochester Way railway bridge then going in a north-easterly direction through Oxleas Wood keeping to the east of Shooters Hill and passing north of Poets Corner (in the London Borough of Bexley), in a north-easterly direc-tion between the Woolwich cemeteries passing to the east of Bleak Hill and then going in a generally northerly direction between Plumstead and Abbey Wood, then in a generally north-westerly direction through Thamesmead across the River Thames at Gallions Reach to a point about 239 metres (261 yards) north-west of the north bank of the River Thames at Beckton, in the London Borough of Newham, in pursuance of the A406 London North Circular Trunk Road, Slip Roads and Bridge) Order 198, b the constituction of a main new trunk road about 2.34 Borough of Greenwich, about 350 metres (383 yards) west
- (b) the construction of a main new trunk road about 2 34 b) the construction of a main new trunk road about 2 34 kilometres (1 45 miles) in length starting at a point about 239 metres (261 yards) northwest of the north bank of the River Thames at Gallions Reach and extending generally north-westwards and then generally northwards through the Beckton Gas Works to join the South Woodford to Barking Relief Road, at Beckton in the London Borough of Newham, in pursuance of the A406 London North Circular Trunk Road (East London River Crossing (A13 to A2) Supplementary Trunk Roads and Slip Roads) Order 198 Order 198
- (c) the construction of slip roads to connect the main new the construction of slip roads to connect the main new trunk road referred to in (b) above with a proposed new highway to be constructed at Winsor Terrace (in pursuance of the A406 London North Circular Trunk Road (East London River Crossing (A13 to A2) No 2 Supplementary Side Roads Order 198), at Beckton in pursuance of the Supplementary Trunk Road and Slip Roads Order,
- (d) the construction of slip roads to connect the main new trunk road referred to in (b) above with the proposed South Woodford to Barking Relief Road and A13 Interchange (in pursuance of the A13 London to Tilbury Trunk Road (Roundabout near Gooseley Lane and Slip Roads) Varia-tion Order 1985) at Beckton, in pursuance of the Supple-mentary Trunk Road and Slip Roads Order,
- (e) the construction and improvement of highways and the provision of new means of access to premises in the London Borough of Newham, in pursuance of the No 2 Supplementary Side Roads Order, and
- (f) use by the Secretary of State in connection with such construction and improvement of highways and the execution of other works mentioned above

(2) The land described in Schedule 2 hereto for the purpose of mitigating any adverse effect which the existence or use of certain highways proposed to be constructed or improved by him as mentioned above will have on the surroundings thereof
