**NOTE**—The land comprised in each item in Schedules 1 and 2, is identified on the plan referred to in the draft No 2 supplementary compulsory purchase Order by means of the number or numbers shown in brackets against that item in the schedules

##### *In the London Borough of Greenwich*

The right to construct and maintain a bridge over part of river bank and mud flats on the south of the River Thames, and part of bed of the River Thames, at Gallions Reach (389/1 and 389C/1)

##### *In the London Borough of Newham*

The right to construct and maintain a bridge over part of bed of the River Thames at Gallions Reach (389D/1). Part of site of disused storage area, parts of gantry, open area, storage tanks, road, hopper and other buildings within Beckton Gas Works (391/1 and 395B/1). The right to construct and maintain an access road over parts of open area of Beckton Gas Works (391B/1). The right to construct and maintain an access road over scrubland, and allotments south of Beckton Gas Works (394/1) (in unknown occupation). Site of part of factory yard at Winsor Terrace occupied by Canada Dry Rawlings Ltd, including water tank, pump house, part of effluent tank and part of workshops (399/1). The right to lay and maintain a drain pipe in part of factory yard at Winsor Terrace occupied by Canada Dry Rawlings Ltd (399A/1). Site of part of effluent tank and surrounding area within factory at Winsor Terrace occupied by Canada Dry Rawlings Ltd (399B/1). The right to lay and maintain a drain pipe in roadway known as Roding Road adjacent to Beckton Gas Works (399C/1). Site of part of workshops and part of surrounding area in factory at Winsor Terrace, occupied by Canada Dry Rawlings Ltd (399D/1). Parts of open area in Beckton Gas Works (400/1 and 400A/1). The right to construct and maintain a bridge over parts of disused storage area within Beckton Gas Works (400B/1 and 400C/1). Part of southern slope to the embankment over the Northern Outfall Sewer (401/1 and 401D/1). The right to construct and maintain a bridge over parts of embankment and access track over the Northern Outfall Sewer (401A/1). Parts of north slope to the embankment over the Northern Outfall Sewer (401B/1). Part of north slope to the embankment over the Northern Outfall Sewer, part of sludge lagoon, part

of embankment to sludge lagoon and part of grassland adjacent to the sludge lagoon (401C/1). The right to construct and maintain a bridge over part of lagoon and part of lagoon embankment to the north of the Northern Outfall Sewer (402/1). Parts of the lagoon embankment and part of the lagoon area to the north of the Northern Outfall Sewer (403/1). Part of grazing land and pond south of Claps Gate Lane (404/1).
